# Glossary of Terms

#### Automated Teller Machine (ATM)

This machine can perform some of the transactions a teller can make. They are commonly found at credit unions and banks, but are sometimes placed in other locations such as grocery stores, retaurants, and malls.

#### Point-of-Sale (POS) Terminal

POS is a system that lets you pay for purchases with your Business Debit Card. When you use the POS system, the money you spend for purchases, plus any cash back, is automatically deducted from your Business Checking account. POS terminals are commonly found at the pump at gas stations, check-out lines of grocery stores, and at some retail establishments. Use your Business Debit Card as a debit card everywhere Visa debit cards are accepted. You slide your card through the POS terminal and simply follow the instructions displayed on the terminal.

#### Personal Identification Number (PIN)

Your PIN is the key to using your Business Debit Card; for PIN-based transactions. It is your four-digit secret password that you choose when you receive your card. You enter the PIN at the ATM or POS terminal to authorize a transaction. Your PIN is like your signature on a check.
