

Houston Federal Credit Union Kirby Branch Renovation Celebration Giveaway Drawing Official Rules.

No purchase necessary. A purchase will not increase your chances of winning.

Prize Drawing. All members in good standing entering into the Houston Federal Credit Union (HFCU) Kirby branch during the hours of 11:00 am and 2:00 pm Central Standard Time (CST) on August 3<sup>rd</sup>, 2018 (celebration day) shall have the opportunity, as long as prize quantities last, to submit an entry form for the chance to win a \$25 gift card (prize). By submitting an entry form, each eligible member agrees to these rules.

Prizes. \$25.00 gift cards will be awarded every hour on the hour between 11:00 am and 2:00 pm CST on the celebration day for a total of four (4) awards. Members may only win one prize, and the winning of a prize disqualifies the winning member from receiving any further prize during the celebration. Prizes available may change during the promotional period as quantities diminish.

Other promotional gift items may be available to be given to any person entering the Kirby branch on the celebration day at the discretion of HFCU personnel. These items may include promotional items from HFCU or promotional partners. Recipient must be physically present in order to receive a gift item. All gifts are non-transferable. No substitution or cash equivalent of prizes permitted except at the sole discretion of HFCU. Guest members and community members may receive promotional gift items if available.

Conditions. Drawings will take place every hour on the hour beginning at 11:00 am CST and ending at 2:00 pm CST on the celebration day. All valid entries entered into the drawing, which has not already been selected as a winner, will be eligible for each of the remaining prize drawings. All winning entries will be removed and will not be eligible to win any further prize.

Members must be at least eighteen (18) years of age and in good standing to receive a prize. Eligible members do not need to be physically present at the time of the drawing in order to receive a prize. Officers, directors, employees, and volunteers of HFCU are not eligible to win. Entry form must be completed in person, in the Kirby branch. Only one entry per member will be allowed. If more than one entry is submitted by a member all entries submitted by that member will be voided. HFCU reserves the right to end the contest at any time, without further notice. Guest members are not eligible to win a gift card.

Publicity. Submission of an entry form shall constitute winners' consent to HFCU's use of winners' name, likeness, photograph, voice, opinions, and/or biographical information, for promotional purposes in any media (including the internet) without further payment or consideration.

Taxes. All taxes, fees, surcharges or liabilities relating to a prize are the sole responsibility of the Prize Winner. Payment of any federal state or local taxes will be the obligation of the Prize Winner, and any costs not specifically identified herein are the responsibility of the Prize Winner.

Compliance with Law. All issues and questions concerning the construction, validity, interpretation, and enforceability of these Official Rules, or the rights and obligations of entrant and the Credit Union in connection with the contest, shall be governed by, and construed in accordance with, the substantive laws of the State of Texas, without regard to its choice of law provisions.

Miscellaneous. HFCU reserves the right to cancel or modify the contest at any time. By participating, entrants agree to release, discharge, and hold harmless HFCU, their respective affiliates, officers, directors, and employees from any liability, claims, or damages arising out of their participation in the giveaway or contest and the acceptance, use, misuse, or possession of any prize.
