

GETTING STARTED ON SETTING UP EXTERNAL TRANSFERS

Are you ready to begin moving money between POPA FCU and your other financial institutions? Please read the terms and conditions before beginning any external transfers.

Also refer to the steps in this guide on adding other financial institutions to transfer to and from your POPA FCU account.

ADDING EXTERNAL ACCOUNTS

- From the main menu tab bar, click *Transfers* → *External Account Transfers* → *Add External Account*. (see figure 1)

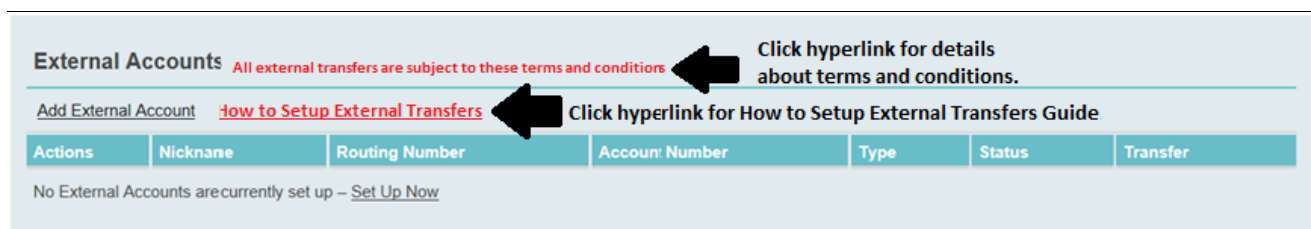

ADDING EXTERNAL ACCOUNT INFORMATION

- Complete the *Add External Accounts* form. All necessary information can be found on one of your personal checks, or by calling your other financial institution for assistance. (see figure 2 A/B)

CONFIRMING ACCOUNT INFORMATION

- If all of the information appears to be correct, click *Save*. (See Figure 3)

REVIEWING YOUR STATUS

- Once the new account information has been entered, it will show up as *New*. You will receive two small deposits into your other financial institution’s account within the next one to two business days. Once this occurs your POPA FCU status will change from *New* to *Verify*. Click on *Verify*, enter the two deposit amounts and click *Submit*. (See Figures 4A through C)

- You will need to determine the amount to be transferred, select the accounts the funds will be transferred to and from and the frequency of the transfer. (See Figure 6)
